Due to the significant risk of the spread of the coronavirus, various restrictions have been put in place and many companies are working in a limited direct contact mode. Additionally, the services provided by courier and airline companies also do not guarantee that the foreign bidder's offer will arrive within the specified time frame.	Please note that the application must be submitted in paper form. As per Additional Information, point 23, applications must be submitted in English exclusively to the contracting authority in a sealed envelope either by post or by courier service, or hand delivered by the participant in person or by an agent directly to the premises of the contracting authority.  Also, in accordance with point 24, The candidate's attention is drawn to the fact that there are two different systems for sending applications: one is by post or private mail service, the other is by hand delivery.  In the first case, the application must be sent before the date and time limit for submission, as evidenced by the postmark or deposit slip, but in the second case it is the acknowledgment of receipt given at the time of the delivery of the application that will serve as proof."
