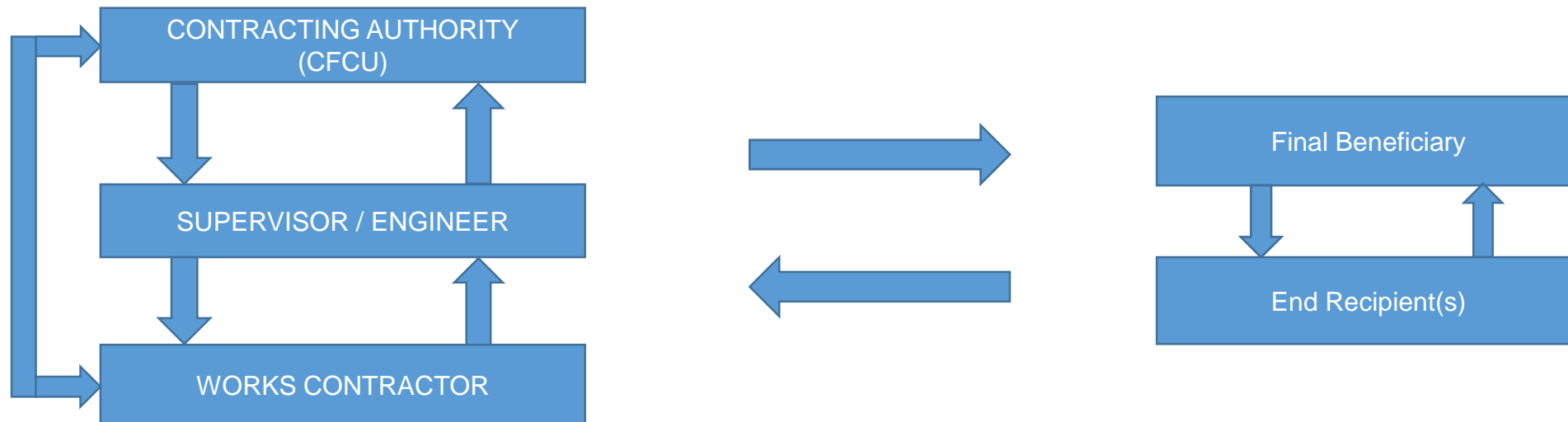


## PROCEDURAL DETAILS
